Hospices & skilled nursing facilities: Report all managing employees

CMS: mlnconnects; 2/8/24

CMS recently clarified that hospice and skilled nursing facility medical directors and administrators are always considered managing employees for Medicare provider enrollment purposes. You must report all current managing employees. If you haven't reported a medical director or administrator, report them now. Concurrent Medicare hospice & curative care improves quality & reduces costs 13%

Medicare beneficiaries with terminal health conditions who participated in the Medicare Care Choices Model (MCCM), received high quality care at a 13% lower cost compared to similar beneficiaries who did not receive the MCCM services. The Centers for Medicare & Medicaid Services (CMS) tested this new model as an option for Medicare beneficiaries to receive supportive care services while continuing to receive services for their terminal condition.

Five years after investor-owned HCA Healthcare took over an esteemed nonprofit hospital in North Carolina, Medicare is threatening to cut off payment for any services it provides seniors. The rare and dramatic move follows a Medicare revelation that patient safety is in "immediate jeopardy" at Mission Hospital in Asheville. That designation is the most severe the agency can hand out. New paths could allow medical aid in dying for people with dementia

This hasn't been allowed up until now but that could soon change, which could have implications for physicians, according to a new report.

An 85-year-old former doctor from Arizona is facing manslaughter charges for allegedly aiding in a suicide of a woman at a New York motel last year, according to authorities.

Medical assistance in dying bill draws large turnout

People in wheelchairs, others relying on crutches, some facing terminal illness and some caregivers packed a hearing Wednesday for a bill that would allow medically assisted dying in New Hampshire. While most of the attendees expressed support for House Bill 1283 to help those enduring pain during the final stages of life, Jonathan Eddinger, president of the state board of medicine, advocates for a shift in focus toward improving the ability to alleviate pain and suffering rather than making death an option to end such agony.

Senior living providers can tap into \$25 million grant to develop dementiaspecific respite services

Senior living operators who provide, or are considering providing, respite services for family caregivers of people living with dementia can apply for a piece of \$20 million in grant funding. The Alzheimer's Association will use a \$25 million, five-year grant award from t he US Department of Health and Human Services' Administration for Community Living to establish a new Center for Dementia Respite Innovation tasked with making respite services and service providers more dementia-capable.

Amedisys rolls out in-home testing to reduce hospitalizations

Home health provider Amedisys said Thursday it will begin offering in-home molecular testing to patients that will help quickly identify urine, respiratory and wound infection pathogens.

Study highlights financial burden of dementia on older adults, families

Georgia State University - School of Public Health, by Sam Fahmy; 2/7/24

A team of researchers from the Georgia State University School of Public Health, the University of Washington School of Pharmacy and the University of California San Francisco analyzed data from a national sample of more than 4,500 adults aged 70 and older to arrive at what are thought to be the first comparisons of out-of-pocket expenses by dementia status and care setting. The researchers found that the median adult with dementia in residential facilities such as assisted living centers spent 97% of their monthly income on lo ng-term care. People with dementia in nursing homes spent nearly 83% of their monthly income on long-term care.

Humana eyes \$700M cuts amid \$541M loss

Modern Healthcare, by Nona Tepper; 1/25/24

Humana plans to trim \$700 million in administrative expenses after recording a disappointing fourth quarter and 2023, the company announced Thursday. The health insurer warned investors last week that medical costs exceeded expectations in 2023. On Thursday, the company disclosed that expenses were \$3 billion more than anticipated. Quarterly and annual earnings didn't meet projections amid rising costs and disadvantageous Medicare Advantage policies.
