As Medicare Advantage grows bigger and bigger, there's one area the industry and regulators haven't figured out how to make work yet: hospice.

Why it matters: The end-of-life care option is the only Medicare service that can't be offered in the private-run alternative, which now covers over half of enrollees. ...

Catch up quick: Usually, when a Medicare Advantage beneficiary decides to enter hospice after receiving a terminal diagnosis, traditional Medicare pays for this care while they remain enrolled in their private plan. ...

National Nurses Week 2024: RN reflects on the state of the profession, calls for change

USA Today / Columbia Daily Tribune; by Julia Gomez, USA Today; 5/6/24 Monday, May 6 kicks off National Nurses Week, and it gives folks an opportunity to show their love and appreciation for the people who take care of the sick, injured and dying. From neonatal nurses who help welcome newborns into the world to hospice nurses that provide peace and comfort to their dying patients, nurses play a crucial role in the medical industry. ... Catherine Kennedy, a registered nurse and the Vice President of National Nurses United, told USA TODAY that there needs to be systemic change on the federal level to give nurses the best chance to care for their patients. A study published by the National Library of Medicine states that in 2021, nurses would work an average of "8.2 hours of paid overtime and 5.8 hours of unpaid overtime per week that year — making up the equivalent of more than 9000 full-time jobs." ...

Hospice patient airlifted to safety during East Texas floods

Willie Rawls woke up to water at the steps of his home Thursday in the river bottoms of Coldspring – one of the first towns hit by the several hundred thousand gallons of water released from the Lake Livingston Dam. The dam was releasing water in an effort to maintain its levels as merciless rain storms drenched East Texas this week. Rawls, 73 and in hospice care, was evacuated by

the San Jacin to Sheriff's Office, who arrived in an airboat and lifted him to safety.

At Essentia Solvay Hospice House, workers across the board, including Registered Nurses, License d Practical Nurses, Nursing Assistants, Administrative Assistants, Environmental Services workers, and Cooks, filed for a union election.

Elder abuse is easy to miss

Here is what to look for if you suspect a caregiver--whether a relative or a professional--is mistreating a loved one. ... People are living longer in their own homes outside of nursing homes or other institutional settings, which means that at some point each of us is likely to be a caregiver or looking for continuing health care for a loved one or ourselves. ... "My husband was in home hospice for the last months of his life." ... [A bereaved caregiver describes incidents with her husband's care.] Then I ... went to the other room and called the agency's 24-hour number. 'I want her out of here,' I said. 'Please send someone else as soon as you can.' Lou briefly rallied the next morning, but he died later that day. Did the aide hasten his death? I believe she did."

Chesapeake Life Center offers monthly LGBTQIA+ drop-in grief support group

Chesapeake Life Center will host a monthly drop-in grief support group for members of the LGBTQIA+ community. ... Grief is a hard and vulnerable time, and it is important to have safe spaces to process what we are going through. This group is intended for adult members of the LGBTQIA+ community who are grieving a past or approaching death. The group will be facilitated by a licensed queer therapist but will be loosely structured to offer an opportunity for participants to share their feelings and grieve with community.

... Melbourne artist Jeffrey Kelson is known for his thought-provoking portraits, several of which have been exhibited at the Melbourne Holocaust Museum. He believes a portrait is a window into a subject's heart and mind. However, after being diagnosed with late-stage pancreatic cancer, it wasn't this style of art that Mr. Kelson was drawn to. As soon as he felt well enough to return to his studio, he started work on a series of colourful collages. "At one point, my wife came into the room and commented on how bright they wer e and how full of life force. She was surprised that I could create pieces that were so energetic when I felt so ill. I hadn't really thought about it. I just needed to work," he told *InSight+*. ... Palliative care specialist Dr Eric Fairbank was one of Mr Kelson's art students for several years before Mr. Kelson's diagnosis. He said Mr Kelson's approach to his diagnosis has confirmed his belief that the best outcomes of cancer treatment are achieved when they're complemented by the patient's own resources of mind, will and spirit. Objective: This hypothesis-generating study sought to assess the impact of home-based hospice and palliative care (HBHPC) provider home visits (HV) on healthcare use.

Conclusion: HBHPC provider HVs were associated with fewer inpatient admissions, hosp ital days, and intensive care unit days, and increased clinically relevant phone calls and phone calls before emergency department visit. These findings indicate that HBHPC HV may contribute to decreased inpatient use and increased use of the HBHPC team.

Pro-life hospice group launches 'Do Not Euthanize' Registry to protect Canadians patients

One of Canada's only fully pro-life hospices, the Delta Hospice Society (DHS), has launched a new Do Not Euthanize (DNE) National Registry that it says will help "defend" vulnerable citizens' lives from "premature death by euthanasia." Angelina Ireland, executive director of the DHS, told LifeSiteNews that the new DNE National Registry is live as of May 1, 2024, with the goal being to have everyone who has already signed, or will sign, a DNE, added to the registry.

Scotland Regional Hospice Golf Tournament garners \$180K
